HOMEOWNER FORUM PROCEDURE

Tonight's Homeowner Forum is for the purposes of hearing owner concerns and sharing ideas. Please note the following:

1. This is a meeting of the association's Board of Directors and is open to all association members. Tenants may not attend without special permission from the Board of Directors.
 2. The California Open Meeting Act prevents the Board from taking actions on items not on the posted agenda except to briefly respond. If your issue tonight was not on that posted agenda, we may not be able to address it in its entirety unless it can be deemed an emergency. The term "emergency" is defined in Code as something that is unforeseen and requiring immediate attention.
 3. Disruptive or rude behavior will not be tolerated. If you are disruptive or rude, the Board may choose to adjourn the meeting for a brief recess, or if the behavior does not improve, adjourn to another date, time and location.
 4. Each member is afforded up to five minutes to speak. If several of you are here for the same topic, please select one or two speakers so the Board can conduct its regular business in a timely manner.
 5. Once the forum is over, the Board will conduct its meeting during which members have an opportunity to observe, but not participate in discussion or deliberation unless asked to by a majority vote of the Board.
